## Covid

## Boating Legislation for Derelict Boats \$18.7 Million

Our new Governor has added a 1-time line item of \$18.7 million dollars for removal of derelict boats. The money is coming from the settlement from Monsanto that was awarded to the state for clean-up. The budget money requires a program be put in place first before the money can be spent. HB2914 establishes an 18-person task force. The purpose of the task force is to study and make recommendations on laws governing the seizing and disposing of abandoned vessels and derelict vessels. Specifically, the task force shall prepare a report and present it to the Legislature by Sept 15, 2024. The task force will include many agencies and also several members from the marina and fishing industry. The house bill and budget are not official yet but are working their way through the legislative process with a "do pass "Recommendation.

## Security- Do Not Give Code to Amazon or Other Carriers

Just a reminder to not give your gate code to carriers to deliver packages to your home. When you give out your code you compromise the security for everyone in the marina. Most drivers are still temporary drivers, and you have no idea who they may give that code to. We are installing lighting above the package drop boxes to make it easier in the dark to find your packages. The regular UPS and FedEx already have their own access codes.

## **Summer Work Projects**

-We are finished with the decking work for the summer and will start back up late fall. We will be putting vinyl siding on the middle and lower bathrooms and complete the trim.

-We will be installing a decorative concrete stack block wall in the upper main parking lot on the railroad side. We will be removing the old railroad ties that are about all rotted out. And yes, we are going to transplant the daffodils up about 6 feet from the edge. - Of course, we will be taking care of any needed projects or emergencies that come up.

#### **Boater Information**

- Our dock staff has started washing boats that are an eyesore with lots of green slime. We added a
  water pump and pressure washer to our workboat so we can wash the back of the boats where you
  cannot reach. We are not charging for this service, nor do we offer boat washing services. We are just
  making our marina look nice for everyone to enjoy. You are responsible for cleaning your own boat. We
  only are washing off the heavy slime.
- All winter tarps are to be removed by May 1<sup>st</sup>.
- Remember we have a 6-month minimum for boat moorage. If you get a summer slip you will be billed for 6 months
- Remember that a 30-day notice is required when vacating your slip.
- Register your boat.
